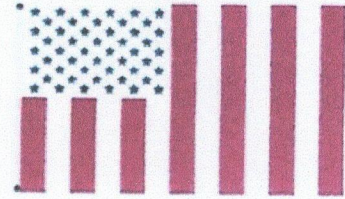

**The Idaho Assembly**  
**The** United States of America (unincorporated)

**Idaho Public Law 17.12.2020, December 18th, 2020**

***Let it be known that this Seventeenth Day of December, Two Thousand and Twenty, The People upon the Land and soil of Idaho, exercising our Lawful authority as The Idaho Assembly and sole Lawful Government of Idaho, do hereby enact this Idaho Public Law:***

It shall be unlawful for any Incorporated (Public) entity operating within the physical borders of Idaho to mandate or demand under color of law, statute, or regulation, that any member of the Idaho Public **be required to** participate in behaviors of a Medical Nature without express Authorization by The Idaho Assembly and Idaho Coroner, subject to a fine of not less than \$75,000.00 and not more than \$1,000,000.00 per instance of unlawful demand/mandate.

Repeated or ongoing unlawful Mandates/Demands of behaviors of a Medical Nature may result in revocation of the Incorporated Entity's charter to do business within the physical borders of Idaho, subject to the discretion of The Idaho Assembly.

Mandate(s) or demands of a Medical Nature are hereby defined within Idaho Public Law to include, but not be limited to: the forced wearing of a face Shield, Covering, or Mask, restriction or closure of businesses, "Social Distancing," travel restrictions and/or forced vaccination.

Fines to be imposed upon Principals, Agents, Employees, and Assigns, jointly, severally and individually liable.
