

Dear Governor Bradley J. Little,

I, David Leo Torres, in my Lawful Capacity as Coordinator of, for and in behalf of *The Idaho Assembly*, in good-faith, honor, standing, and peace, extend to you cordial and amicable greetings.

I am writing to you in behalf of *The Idaho Assembly*, to provide you with Lawful Due Notice that *The Idaho Assembly*, the properly constituted civilian Land and soil jurisdiction government for Idaho, is in-session. 3. As American State Nationals and American State Citizens, we are being needlessly harmed and inconvenienced by the continued suppression of the Idaho economy.

4. As American State Nationals and American State Citizens, we are not subject to any "Executive Orders" or "Declarations of Emergency" issued by your Office, since these only pertain to Government Employees/Officials/Dependents exclusively.

5. Our government has been in a state of Peace continuously since 1814, and as such, we are neither combatants nor participants in any nominal "War on the common cold." We as Americans are owed **The Law of Peace** as enumerated in **Department of the Army Pamphlet 27-161-1**, good-faith service, amity, and protection from all "County of County," "State of State," and Territorial/Municipal/Federal Employees.

6. That no Corporate State of State/"STATE OF STATE" or Federal/Territorial/Municipal officer or employee may suspend the Constitutional Guarantees owed to American State Nationals/American State Citizens for any reason (including a purported "viral outbreak"/"Live Exercise"). 7. We thoroughly rebut any and all presumption we are now or ever have been 'Residents' or 'citizens' of the fictional "State of Idaho"/Territorial or "STATE OF IDAHO/MUNICIPAL" inchoate corporate "States," both of which are entirely foreign entities with respect to us as Americans.

8. As such, we strongly object, stringently protest, and absolutely do not consent to any forced "vaccination program" or other forced/involuntary, untested medical procedures which would only apply to your Employees and Dependents.

9. You are hereby provided Due Notice of our **Fee Schedule**: for any harm caused to living American people upon Idaho Land and soil by any foreign Corporate "Government Service Providers," agents, or subcontractors, be they "County of County," "State of State," or Territorial/Municipal/Federal, a fee of \$1,000,000,000.00 will be assessed.
